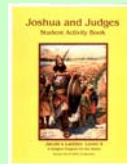
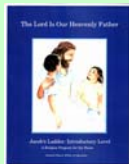

STANDARDIZED IOWA TESTING

Orders for standardized testing, including payment, must be received by November 1. Late applications will be returned. Iowa test materials are distributed in mid-February, with the actual testing to take place between February 23 and March 20. Completed tests and booklets must be returned to the central office by March 27 for scoring. Results are typically sent to parents by mid-May and include information for interpreting scores. Testing fee is \$40 per student for 2011-2012. Please note: testing supervision requirements vary from state to state.

LOANS AND FEES

Our resources are shared each year by many home school families and school classrooms. Our service depends on the cooperation and support of each program member to assure that we will be able to serve all of our members.

- I agree to return loaned unit boxes by the dates they are due (usually 4-6 weeks from the start of the loan).
- Full payment of fees, or a payment agreement is required to receive services.
- I want to find out about scholarships.
- I agree to pay the following fees, if applicable:
 - Late fines
 - Replacement cost of lost or damaged items.
 - UPS shipping charges for items sent to me, billed quarterly.

I understand that up to 50% of the registration fees may be refunded until October 1, 2011 at the discretion of the program director. I understand that registration charges are non-refundable after this date.
